

## **Hot Cross Bun Promotion – Bay Central 2025**

- The Promotion commences at 09:00 Sunday 13 April and concludes 14:59 Tuesday 15 April 2025 (the “Promotion Period”).

  - \$25 or more in any participating specialty store (stores listed in Table A) or \$55 or more at Woolworths or ALDI, during the promotional period. (The following products are ineligible: tobacco, gift cards, mobile phone recharge, prescription medicines, lottery and alcohol).
- Eligible purchases are purchases made at Bay Central Woollooware Bay between 09:00 on 13 April 2025 and 12:59 15 April 2025.
