 - b. "Closing Date" means 03:00pm [(AEST) on Thursday 17 April 2025
 - c. "Determination Date" means 03:00pm (AEST) on Thursday 17 April 2025
 - d. "Entrant" means a person who enters the Promotion.
 - e. "Prize" means a prize offered in the Promotion.
 - f. "Promoter" means Twentieth Letter Marketing and Communications Pty Ltd - ABN No. 67 138 747 029 as the marketing agent for Bay Central Woollooware, 453a Captain Cook Drive, Woollooware Bay NSW 2230.
